#### Page 12

Elias Blackburn Junr. is appointed overseer of the road from Daniel's Mill to the three Notch'd [Road?]. Ordered that John Pickett, James Pickett, George Greens, Mary Williams, Thomas Mays, Samuel Boudry and Mace Pickett's people assist him in clearing the road.

Mary Binion being admitted to choose a guardian made choice of John Murrill. John Murrill with Wm. Binion his security acknowledged bond.

John Young is admitted guardian to Jerusa Hurt and also assigned guardian to Anna and Philemon Hurt. John Young with Edmond Pendleton Gent., his security, acknowledged bond.

John Partlow's deed of gift to his son John Partlow was proved by Wm. Oliver and Edward Baber.

John Newport vs. John Terrell. Pleas before the justices 14 November 20 George II [1746].

John Newport obtained an attachment from Thomas Johnson, Gent., one of his Majesty's justices, against the estate of John Terrell for £26.14.6 current money 9 Nov. 1743. John Taylor, Sheriff, returned by Jo[ ] Pickett his under sheriff that he had levied the attachment in the hands of John Woolfolk. The plaintiff by Zachary Lewis his attorney; Manoah Chiles [for the defendant?] [The defendant refuses to pay] to the damage of the plaintiff £40 current money.

### Page 13

13 July, 10 August, 10 November [etc.] Jury find for the plaintiff [ current] money and 134 pounds of tobacco

[ vs. ] June 1746 came the parties by their attorneys [and state] in 1738 the defendant purchased a tract of land of Za[chary Martin and] gave Martin a writing that he would pay the debts then due from [ to] Turnbull a factor for John Willson, Patrick Barclay and William Marshall.

At a Court held 13 February 1746 [1747] Present: William Woodford, John Taliaferro, Thomas Buckner, Wm. Taliaferro, Gent., justices. It's ordered the road Joseph Woolfolk petitioned for have turned stand according to the viewers" report.

Wm. Beverley Gent. acknowledged his deed of land index to Robert Gilchrist.

Present: Robert Farish, Gent.

It's ordered Rice Curtis, Roger Quarles and Richard Morry settle an account of the administration of the estate of Joh Riddle.

Present: Thomas Johnson and Richd. Buckner, Gent.

Thomas Buckner, James Taylor and George Hoomes, Gent., are nominated for sheriff.

Robert Dawson is appointed constable of the precinct in which Charles Benson is constable.

It's ordered the Sheriff summon the children of Wm. Lee, deceased, to appear next Court.

Present: George Hoomes, Gent.

George Wyth Gent. produced a license to plead as an attorney, took the caths, subscribed the Test, was sworn.

On the motion of Edmond Pendleton Gent., Churchwarden of Drysdale Parish, it's ordered the Churchwardens bind out John Frawner son of Edward Frawner.

By consent of the Court, Richard Thilman by indenture binds himself to John Mountague.

Present: Archd. McPherson, Gent.

It's ordered Henry Webster and Ann Oakey be summoned to prove the will of John Gouge.

Ann Eubank and Thomas Eubank's deed to Thomas Fortune was proved by Edmond Pendleton, Francis Taylor and John Pruitt.

Present: John Taylor, Gent.

On the petition of Ann Fletcher, it's ordered Peter Sullinger be summoned to next Court.

It appearing to the Court that Thomas Watts, late guardian to Thomas Riddle, neglects the orphan, by consent of the Court Thomas Riddle makes choice of Edward Herndon to be his guardian.

James Ferguson's deeds of lease and release of land indented to Augt. Leftwich was proved by John Whitlock. after his time is expired sixteen days, being absent eight days from his service.

Petition. Nathan Chapman agt. William Cockerham. Dismissed, no appearance.

Page 97 [8 July 1748]

The plaintiff having proved their account, it's considered by the Court they recover £7.8.- current money. The Sheriff made return he had attached one fodder stack. It's ordered he cause the fodder to be sold and satisfy the judgment.
